Information on customs requirements and regulations in Namibia. All goods and gifts, acquired abroad or in any duty-free shop including goods bought duty free on an aircraft and/or ship are subject to payment of customs duty and Value Added Tax (VAT), when brought into Namibia. - A flat rate.

In order to enter Namibia, certain goods are subject to specific controls and, regardless of their value and quantity, they require the consent of Namibia government, preferably, license must be obtained prior to passage through the customs, preventing the goods from being retained. On this page.

As a member of SACU, Namibia applies a SACU common region-wide import

and export management regime. According to the WTO import licensing agreement, imports are classified into three categories namely automatic, non-automatic and prohibited. Automatic licence imports is defined as import licensing. Where can I find information about import restrictions in Namibia?

How do I report goods to Namibia Customs & Excise?

All goods imported into the Republic of Namibia must be reported to Namibia Customs and Excise through use of a goods declaration lodged at the Customs and Excise office at which they arrive.

How to declare goods for home use in Namibia?
